### **Butler University Law Scholar Application Information**

#### Award:

Two selected scholars will receive:

- a minimum of a half-tuition scholarship to the IU McKinney School of Law. Students already receiving a half-tuition scholarship from IU McKinney may be awarded an additional bump in scholarship as a result of the Butler Law Scholar award, this scholarship cannot be stacked on top of another merit scholarship. A student must maintain a minimum GPA of 2.9 to continue to receive the scholarship throughout their enrollment at the McKinney School of Law. Note: if the student receives a merit-based award that is full-tuition with their admissions offer, the higher award will prevail.

#### **Eligibility:**

- Any Butler University current student or alumnus may apply.
- You must have a completed application to the IU Robert H. McKinney School of Law Fall class submitted through <a href="https://www.LSAC.org">www.LSAC.org</a> by March 1 of the year in which the student is applying to law school. Any application fees will be waived.
- Acceptance and an admission offer from IU Robert H. McKinney School of Law is ultimately required to receive the award. You may apply for the award while still awaiting acceptance.
